Key matters

- At the Blue Water Review (BWR) Working Group (WG) meeting held in Townsville, the following key
 matters were considered:
 - Concept of Operations (CONOPS)
 - Mr Campbell Darby DSC AM presented a CONOPS "strawman" to the Working Group which outlined the fundamental inputs into a CONOPS and sought the WG's support in progressing with the development of a full CONOPS.
 - The Working Group supported Mr Darby's offer to provide a detailed CONOPS at the next meeting in Gladstone.
 - What is a CONOPS?

A CONOPS provides the link between the desired strategic and operational outcomes and the capabilities to achieve those outcomes. It defines how the parts of the organisation operate, the constraints and conditions in which they operate (operational environment) including any key assumptions, and the broad range of activities which support and enable the organisation's performance. The concept also describes the nature of the problem to be addressed, and the character of the various stakeholders as well as their interactions and interdependencies.

For a new Marine Rescue entity, a CONOPS will assist in articulating the operational outcomes expected by the boating public and the enterprise level outcomes expected by Government. From this can be derived the overarching capability needs of the new entity and the potential issues and risks that will threaten success.

A clear CONOPS provides a framework to guide the transition to an efficient and effective Marine Rescue system that has utility beyond its primary blue water rescue role and integrates effectively across the whole emergency service spectrum. A detailed capability and risk review, undertaken at a later stage will have more validity if it is informed by Marine Rescue CONOPS

o Capability Requirements of a Future Marine Rescue Service

The Working Group considered what baseline capabilities a future marine rescue service will require. This discussion involved reflection on the key problems identified in the Report into Marine Rescue Services in Queensland, the key risks in not delivering capabilities in the future and the key benefits of having clearly defined capabilities against risk profiles in local communities. The Working Group then worked to identify gaps between the capabilities agreed upon for a future service and current capabilities.

• Potential Structures of a Future Service

 The Working Group considered how the capabilities required for a future service may inform the future structure. Several options were considered as to how structure might deliver capability. <u>The Working Group has not finalised a view</u> <u>on structure.</u>

• Funding Expectations

- The Working Group held a session with QFES Deputy Commissioner Doug Smith discussing funding expectations for a future service.
- In addition, an informal BBQ was held on Saturday, 25 May, at QF8 Townsville. The evening provided an opportunity for the Working Group to engage with approximately 100 volunteers from as far north as Tully and as far south as Mackay. The minutes from the night can be found attached to this communique.

Key outcomes

The next BWR WG meeting will be held in Gladstone over 8 – 9 June 2019. An engagement session will be held on the evening of Saturday, 8 June at VMR Gladstone with invitations extended to volunteers between Yeppoon and Hervey Bay.
